

## 1. EMPLOYMENT, BUSINESS, TRADE, PROFESSION, OFFICE OR VOCATION

(Para 10 (2) (a) (i & ii) of the Code of Conduct:

You must regard yourself as having a personal interest in any business of your authority if it relates to, or is likely to affect -

- any employment or business carried on by you;
- any person who employs or has appointed you, any firm in which you are a partner or any company for which you are a remunerated director)
- 1.1 Please list every employment, business, office, trade, profession or vocation in which you have a personal interest, including the name of your employer.<sup>1</sup>

<sup>(</sup>iii) any firm in which you are a Partner; or

<sup>(</sup>iv) any company for which you are a remunerated Director.

#### 2. SPONSORSHIP/ELECTION AND OTHER EXPENSES

(Para 10 (2) (iii) of the Code of Conduct:

You must regard yourself as having a personal interest in any business of your authority if - it relates to, or is likely to affect -

- any person, other than your authority, who has made a payment to you in respect of your election or any expenses incurred by you in carrying out your duties as a member)

#### 3. INTERESTS IN COMPANIES AND SECURITIES

(Para 10 (2) (iv) of the Code of Conduct:

- any corporate body which has a place of business or land in your authority's area, and in which you have a beneficial interest in a class of securities of that body that exceeds the nominal value of £25,000 or one hundredth of the total issued share capital of that body)

<sup>&</sup>lt;sup>3</sup>You do not need to show the extent of your interest. A company or body corporate is active in the Fire & Rescue Authority's area if it has land or a place of business in that area. The requirement also covers shares and securities held in the name of other people in which you have a beneficial interest.

#### 4. CONTRACTS WITH THE FIRE & RESCUE AUTHORITY

(Para 10 (2) (v) of the Code of Conduct:

You must regard yourself as having a personal interest in any business of your authority if it relates to, or is likely to affect -

- any contract for goods, services or works made between your authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in sub-paragraph (iv) above)
- 4.1 Please list all contracts, of which you are aware, and which are<sup>4</sup>:
  - (a) contracts for the supply of goods, services or works to the Fire & Rescue Authority or on the Fire & Rescue Authority's behalf, and

<sup>(</sup>iii) any land over which you have a licence;

<sup>(</sup>iv) any land which you have the right to occupy, but neither own nor have a tenancy of (this would include for example informal allotments, use of a field etc).

  - (v) any body listed in paragraphs 10(2)(a)(ix)(aa) to (ee) in which persons described in 10(2)(c)(i) hold a position of general control or management,

to a greater extent than the majority of—

- (aa) in the case of an authority with electoral divisions or wards, other council tax payers, rate payers or inhabitants of the electoral division or ward, as the case may be, affected by the decision; or
- (bb) in all other cases, other council tax payers, ratepayers or inhabitants of the authority's area.
