SUMMARY

The report provides details of the number of Members required for each Fire & Rescue Authority committee. Figures have been based on confirmed members to date, although Members should note that the Vale of Glamorgan Council will not be nominating their Members until the 17th June at the earliest. Final advice will be provided upon the political balance of each committee based on current known Members on the day of the AGM once political groups are confirmed, although adjustments will be required following receipt of the Vale of Glamorgan nominations.

RECOMMENDATION

That Members determine whether the membership of the Finance, Audit & Performance Management Committee is politically balanced or is not politically balanced but contains one representative from each constituent Unitary Authority.

That nominations for membership of each of the Fire & Rescue Authority Committees be received.

That delegated authority is given to the Monitoring Officer in consultation with respective political group leaders to make adjustments to the political composition of each committee once final nominations have been received and to report these to the next available Fire & Rescue Authority meeting

1. ISSUE

- 1.1 Standing Orders provide that the Fire & Rescue Authority is to appoint the committees required by Procedural Standing Order 4.1. These committees are:
 - 1.1.1 Finance, Audit & Performance Management Committee (10 members)
 - 1.1.2 Standards Committee (3 members)
 - 1.1.3 HR & Equalities Committee (15 members)
 - 1.1.4 Local Pensions Board (4 members)
- 1.2 In accordance with sections 15-17 of the Local Government and Housing Act 1989 such committees (with the exception of the Standards

- Committee) are to be politically balanced unless unanimously agreed otherwise by Members. This is a decision for Members to determine.
- 1.3 As Members may be aware, it has been custom and practice for many years within the Authority for the membership of the Finance, Audit & Performance Management Committee to reflect the inclusion of the constituent authorities rather than be politically balanced. This ensures that all ten authorities are represented on the committee where financial issues are considered.
- 1.4 The political balance calculations at Appendix 1 have been calculated on a number of different assumptions. Further advice will be provided at the meeting once membership and political groups have been confirmed. It should be noted that adjustments will be required once the nominations from the Vale of Glamorgan Council are received.
- 1.5 For convenience, the names of the Members who sat on each committee in 2018/19 are detailed in Appendix 2 with those Members who no longer sit on the Authority highlighted in yellow. Members are also reminded of the Independent Remuneration Panel requirements of a minimum 20 days per year time commitment per Authority Member to the Authority when determining membership of committees (and also working groups and outside bodies detailed in later reports), meaning that Members should sit on at least one committee or working group in addition to attending Fire Authority meetings.
