Our response:

South Wales Fire and Rescue Service can confirm that it does hold detail on properties as described however we are unable to provide these specific property identifiers (locations and addresses) at this time. Under Section 36 of the FOIA 2000, to do so would be likely to prejudice the effective conduct of public affairs, in relation to regulatory functions i.e. the prevention of (fire) crime as well as health, safety and security matters.
